# BYLAWS - Part II

## ARTICLE IV -- Elections

### 1. Nominating Committee

Each year no later than October 30, the President shall appoint a nominating committee of at least three members to select nominees for election as officers of The TCA.

### 2. Elections

Election of Officers shall take place during the February meeting of The TCA. The new officers shall assume their duties on the first day of March.

### 3. Vacancies

Vacancies on the Board of Directors will be filled by appointment by the President and announced in The TCA newsletter. These appointments are subject to the approval of a majority vote of the membership at the next regular meeting.

## ARTICLE V -- Duties

### 1. President

The President shall preside at all meetings of The TCA and the Board of Directors. He shall be a member ex-officio of all committees except the nominating committee, and shall perform all other duties usually pertaining to the office.

### 2. Vice President

The Vice President shall preside at meetings in the absence of the President. He shall be responsible for scheduling the midmonth activities.

### 3. Recording Secretary

The Recording Secretary shall maintain an accurate record of the chapter meetings. Minutes of the membership meetings shall be published in the newsletter. The Recording Secretary shall coordinate and maintain records of all chapter correspondence.

### 4. Secretary-Treasurer

The Secretary-Treasurer shall maintain an accurate record of all of the monies received and disbursed. An annual financial report shall be published in the March newsletter. This reporting period will cover the previous March through February transactions.

### 5. Directors

It shall be the responsibility of Directors to assist in formulating chapter policy and operational decisions. Directors may serve on committees and shall assist the President as he directs.
