Feron For Your Corvair

CFC Regulations and Your Corvair Pete Tinucci

Editor's Note: In the fast changing world of R12 phaseout, there are a lot of differing strategies for replacing Freon. Before attempting any work on your system, verify your actions with several sources and maybe even call the EPA. It appears that the printed facts vary depending on which reference source you use.

I have some comments to make about Larry Claypool's article in the November Airhorn. His information is not 100% correct. The information that I am now offering is based on my work experience (7½ years) in the industrial refrigeration field, my 20 years experience in automotive repair and modification and the "Final Rule to Implement Regulations for Recovery, Recycling, Reclamation and Disposal of Used Refrigerants and The Reduction of Refrigerant Emissions" issued pursuant to Section 608 of the Clean Air Act Amendments of 1990.

As for the new rules and regulations, most people in the automotive repair field have not been properly informed. I am not sure why this is, so I am offering the following summary for your information.

All technicians working on MVAC (Mobile Vehicle Air Conditioners) must be certified.

For industrial and all other refrigeration (Non MVAC) certification is not required until November 14, 1994.

In order to be certified, a closed book test must be taken and passed and your company must have a certified recovery or recycling system registered with the EPA.

People in the business of disposing of small appliances and MVACs which have refrigeration systems containing less than 5 pounds of refrigerant are not required to be certified, but they must use a certified recovery or recycling system.

As of November 14, 1994, no one can purchase any refrigerant without possession of a valid certification identification card.

Recovery or recycling must be used for all Class I or Class II substances. For example, Class I includes all CFCs (including R12, R502, Halon). Class II includes all HCFCs (including R22, R123, R141b, R124).

Production phaseout of Class I substances with the exception of essential uses by January 1, 2000.

No new products will use HCFCs after January 1, 2020 and total phase out by January 1, 2030.

Use of HCFCs as propellants for acrosols and foams are banned as of January 1, 1994.

All CFC usage regulations will apply to HFC refrigerants (R134a, HP62, HP81) by November 12, 1995.

As for converting your Corvair, there are several alternatives. First, copper is not effected by R134s. Most industrial, commercial and residential R134s refrigeration systems are comprised of mostly copper tubing. So

the section line on your Corvair is just fine. The drier does require replacement due to the incompatibility of the desiceant and the Polyol Ester oil required with R134a.

There is an interim replacement for R12. This is called MP39. This refrigerant is the closest to a "drop-in" that there is. You would need to replace at least half of the oil in the system with alkylbenzene oil or completely flush the system and use polyol ester oil. A new drier is required only as standard practice unless you use polyol ester oil which requires a different type of drier due to incompatibility. The only problem with MP39 is that the existing expansion valve may be slightly too large. But it most likely will not be a problem.

The use of R134a is a bit more complicated but not impossible. The system must be flushed out to remove at least 95% of the original mineral oil lubricant. The compressor must be fitted with a new type of shaft seal (if available) or replaced with a new R134a compressor. The drier must be replaced with one compatible with polyol ester oil. The flexible hoses must be replaced with nylon lined hose because the R134a molecules are small enough to pass through the regular hoses. Any flare fitting must be replaced with O-ring fittings. I don't see a problem with the barb fittings provided they are in excellent condition. If they are damaged, new O-ring fittings could be welded or brazed to the condenser, evaporator and suction line. The pressures of R134a are identical to R12 in the range that automotive refriguration systems operate. The polyol ester oil is 100 times more hygroecopic (ability to absorb moisture) than the mineral oil used with R12. Therefore, extra care must be taken when the system is opened to the atmosphere. It is recommended that the system be open for a maximum of 15 minutes. Moisture is very difficult to remove even when using heat and vacuum combined.

Remember, these two refrigerants are alternatives. B12 is still available and will be available for quite some time, not as new refrigerant but as a recycled refrigerant. Yes, it will be expensive, but most likely it will be cheaper than the cost of refitting your car with alternate refrigerants.

Some of you may have read that the mejor auto makers do not recommend the use of MP39 as a replacement for R12. This is because MP39 is an interim refrigerant. Their concern is for long-term replacement only. Remember, they are in the business of selling new cars, not repairing old cars. In industrial and commercial applications, MP39 is becoming a very viable replacement for 12

Overall, there are alternatives for Corvair and other older car owners, so you need not be too concerned. The only thing that you will be sure to have is higher A/C repair bills.






